



# NDA Operator Membership Application

(Operators in the United States and Canada Only)

The NDA is the sanctioning body of electronic darting, dedicated to the standardization, recognition, promotion and growth of competition worldwide.

QUALIFICATIONS

### To be eligible for NDA membership, a coin amusement operator must:

- Complete an application on forms provided by the Association.
- Have been actively operating a coin amusement business for not less than two years in the state or province for which application is made.
- Be a member of the Amusement & Music Operators Association (AMOA).
- (A) Own and operate **not less than four electronic dart machines in not less than four locations** other than his/her principal place of business and **own and operate not less than 20 other coin amusement, music or vending machines in not less than four locations other than his/her principal place of business.**  
OR
- (B) Own and operate **not less than twelve electronic dart machines in not less than four locations** other than his/her principal place of business. In addition, **at each location, there shall be not less than two other coin amusement, music or vending machines owned and operated by applicant** and accessible to Association-sanctioned league players during competition.  
OR
- (C) Own and operate **not less than thirty electronic dart machines in not less than four locations** other than his/her principal place of business. In addition, the applicant **must submit at least three letters of recommendation from current AMOA-NDA Charter Holders.**

- Demonstrate that he/she is capable of operating, promoting and coordinating electronic dart leagues and enjoys a good business reputation for honesty and fairness in the coin amusement business.

## CODE OF ETHICS

We shall not engage in illegal activity involving moral turpitude or in conduct involving dishonesty, fraud, deceit or misrepresentation.

We shall not make a material false statement, nor deliberately fail to disclose a material requested fact, in connection with the application for membership in the AMOA-National Dart Association, nor shall a member further the application for membership of any person or entity who is known to be unqualified for membership.

We shall cooperate with all public officials and government agencies in every proper way and shall comply with the laws and regulations applicable to the coin amusement industry, including without limitation those relating to fair competition, restraint of trade and consumer protection.

We shall always maintain our equipment and playing facilities at high levels of repair and cleanliness such as will encourage league play on equipment owned and operated by operators, foster the growth of the AMOA-NDA and stimulate competition and growth throughout the coin amusement industry.

We shall, at all times, treat other members and the public with dignity, respect and courtesy.

We shall always conduct ourselves and our business, including league play on equipment owned and operated by operators, in a fair and honest manner, refraining at all times from conduct or practices that inhibit the expansion of electronic dart leagues.

## LETTER OF AGREEMENT

Our company does hereby apply for membership in the AMOA-National Dart Association. If approved for membership:

- We agree to adhere to all Association bylaws, policies, procedures, rules and regulations currently in effect or adopted during our membership period.
- We will be entitled to all materials, benefits and privileges available to qualified Association members.
- We understand that all aspects of the NDA will be offered to us, but that we are not be obligated to incorporate league rules, handicapping, scoring, etc. into our business that are not in the best interest of our league development.
- We understand that our company will have a vote and input into the growth and development of the Association.
- We have read the Code of Ethics and agree to its form and content. We understand that in signing this Letter of Agreement, we promise to abide by the Association's Code of Ethics and its enforcement procedures.
- We agree to promote, encourage and facilitate participation of all dart league players in NDA tournaments including its annual Team Dart International Tournament.
- We understand that, as an NDA operator member, we will be expected to ultimately sanction at least 95% of our dart league players and that failure to do so may affect our annual dues and limit our participation in NDA tournaments.
- We understand that our membership must be renewed annually by June 1.
- The information provided in this application is true and accurate. If this application for membership is rejected, we understand the Association will retain \$75 to defray processing and printing charges associated with this application.
- We also understand that this signed Letter of Agreement must be on file in the NDA office in order to receive our company's charter.
